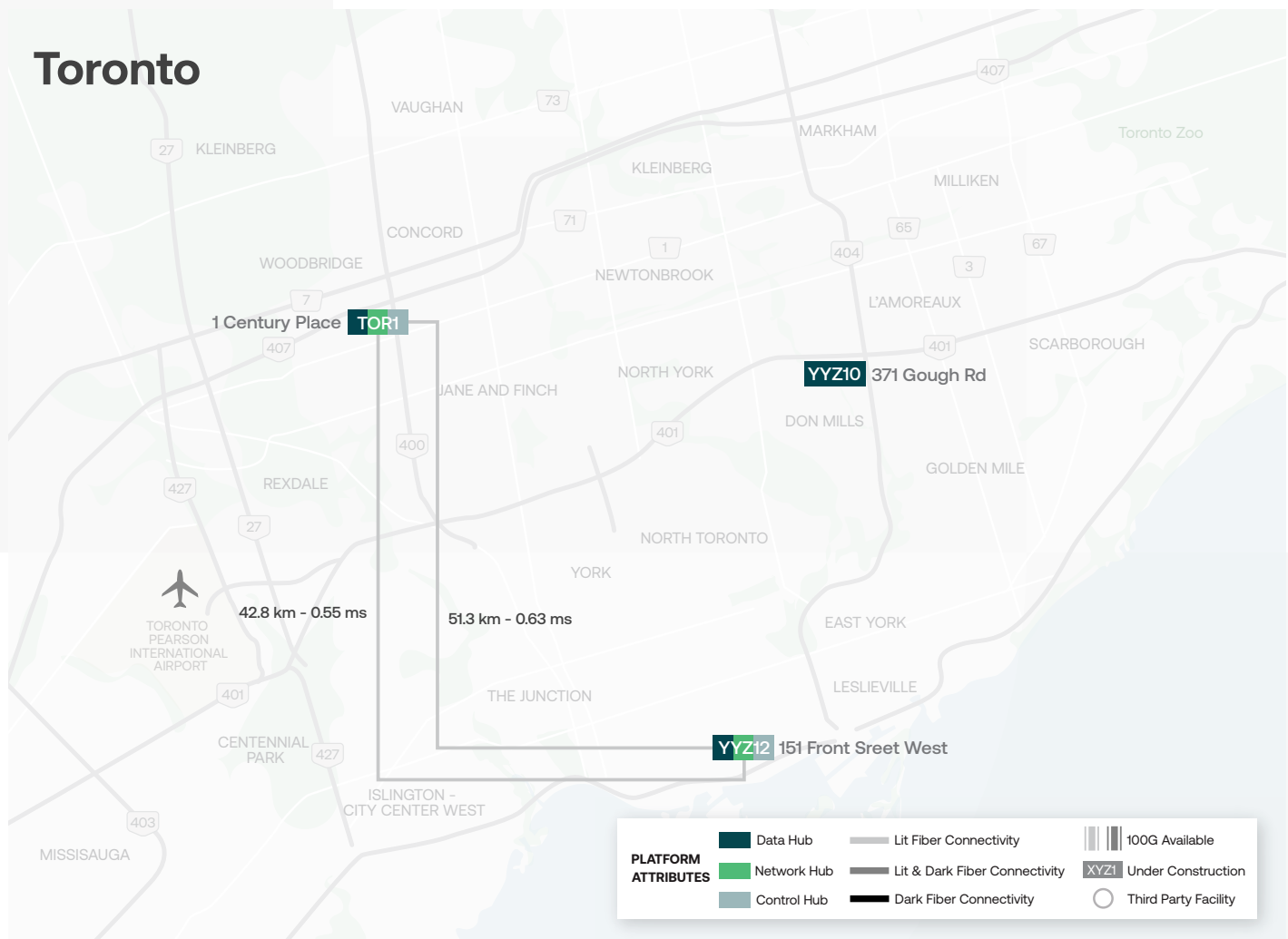


# Why 1 Century Place (TOR1)?
